# Alameda Alliance for Health - Current Status

- TNE increases from (\$6.2 ) million deficit at 6/30/13 to \$75.3 million surplus at 6/30/15 or over 350% required TNE
- Cash \$0.4 million at 12/31/13 now \$349 million at 6/30/15
- Current working capital ratio is 1.2; required ratio is 1.0
- Capital spending controlled; only \$1.3 million for FY2015 compared to FY2013 or 2014
- IT conversion occurred 9/1/2015; no red flags yet
- Claims payment levels timeliness and accuracy compliant
- New call center implemented in August with minor issues; finished August meeting metrics of abandonment rate < 5% and 80% answered in 30 seconds
- Operational functionality much improved; still needs to improve HEDIS scores and Case Management
